- Unless otherwise specified with an asterisk (*), **ALL** fields in the application form have to be duly filled in. Incomplete applications or missing requested documentary evidence will not be processed. In cases of renewal, the expiring card is to be returned with the application.
- The application form should reach the Entitlement Unit at least fifteen (15) working days prior to the departure date to allow for processing and postage of the card.
- Applicants with an ID number ending in (A) should include with their application either proof of their National Insurance Contributions together with documentation to demonstrate the duration of their work contract in Malta or proof that they are married to a Maltese national.
- Persons who work in Malta but pay their Social Security contributions in another Member State are to apply for the EHIC from the country in which contributions are being paid. Pensioners and members of their family who are residing in Malta and who are covered for healthcare in Malta through Reg. (EC) 883/04 and Reg. (EC) 987/09, are to apply for their EHIC from the country paying their pension.
- Children under sixteen years of age should be included in the application of one of their parents.
- Applications are to be sent to the Officer in Charge Entitlement Unit, Ground Floor, Ex-Outpatient Block, St Luke's Hospital, G'Mangia Hill, G'Mangia, Malta.
