(2) Dawn ir-regolamenti għandhom jidhlu fis-seħh fis-7 ta' Marzu 2022:

Izda r-regolamenti prinċipali li qegħdin jiġu emendati bis-saħha ta' dawn ir-regolamenti għandhom jitqiesu li għadhom fis-seħh, inkluż wara s-7 ta' Marzu 2022 għall-finijiet ta' kull att, deċiżjoni, azzjoni jew proċeduri meħuda fir-rigward ta' xi ksur ta' daww l-istess regolamenti.

**2.** Ir-regolament 2 tar-regolamenti prinċipali għandu jiġi emendat kif ġej:

(a) l-ewwel proviso tiegħu għandu jiġi mħassar; u

(b) fit-tieni proviso tiegħu, il-kliem "Izda wkoll il-bars," għandhom jiġu sostitwiti bil-kliem "Izda l-bars,".

**PUBLIC HEALTH ACT  
(CAP. 465)**

**Closure of Food and Drink Outlets  
(Amendment No. 3) Regulations, 2022**

IN EXERCISE of the powers conferred by article 26 of the Public Health Act, the Minister responsible for public health, after consultation with the Superintendent of Public Health, has made the following regulations:-

**1.** (1) The title of these regulations is the Closure of Food and Drink Outlets (Amendment No. 3) Regulations, 2022 and these regulations shall be read and construed as one with the Closure of Food and Drink Outlets Regulations, hereinafter referred to as the "principal regulations".

(2) These regulations shall come into force on 7 March 2022:

Provided that the principal regulations which are being amended by virtue of these regulations shall be deemed to be still in force, even after 7 March 2022, for the purposes of any act, decision, action or proceedings taken in respect of any breach of those regulations.

**2.** Regulation 2 of the principal regulations shall be amended as follows:

(a) the first proviso thereof shall be deleted; and

(b) in the second proviso thereof, the words "Provided further that all bars," shall be substituted by the words "Provided that all bars,"
