It-Tieni Regolamenti tal-2022 dwar Revokar

**PUBLIC HEALTH ACT
(CAP. 465)**

Second Repealing Regulations, 2022

IN EXERCISE of the powers conferred by articles 26 and 27(c) of the Public Health Act, the Minister responsible for public health, after consultation with the Superintendent of Public Health, has made the following regulations:-

1. (1) The title of these regulations is the Second Repealing Regulations, 2022. Citation and commencement.
- (2) These regulations shall come into force on 2 May 2022.
2. (1) The orders and regulations listed hereunder, issued under the Public Health Act, are hereby being repealed: Repeal.

 - (a) Travel Ban Order; S.L. 465.15.
 - (b) Period of Quarantine (Contact with other persons) Order; S.L. 465.23.
 - (c) Enforcement of the Order relating to Self-Isolation of Diagnosed Persons Regulations; S.L. 465.29.
 - (d) Mandatory Use of Medical or Cloth Masks Regulations; S.L. 465.48.
 - (e) Closure of Certain Places of Entertainment Regulations; S.L. 465.50.
 - (f) Closure of Food and Drink Outlets Regulations; S.L. 465.54.
 - (g) Organised Mass Events Regulations; S.L. 465.57.
 - (h) Enforcement of the Order relating to Closure of Places Open to the Public Regulations; S.L. 465.63.
 - (i) Closure of Schools Order; S.L. 465.64.
 - (j) Regulations on Sports Activities; S.L. 465.66.
 - (k) Closure of English Language Teaching Schools Order. S.L. 465.68.

(2) All those protocols or standards issued under any of the regulations or orders which are being repealed by virtue of these regulations shall also be repealed:

Provided that the Superintendent of Public Health may, by means of standards, provide for the requirement to wear a visor or medical or cloth mask:

(a) on airplanes during flights;

(b) in hospitals;

(c) in medical clinics; and

(d) in old people's homes and in care homes for persons with disability:

Provided further that the Superintendent of Public Health may also, by means of standards, provide for the requirement that a person recovered in hospital or residing in an old people's home, submits to a period of quarantine, if such person is recovered or resides, as the case may be, in the same room with another person who results positive to COVID-19.

3. Any act, decision or action taken before the coming into force of the Second Repealing Regulations, 2022, shall remain to be regulated by the provisions of the regulations and orders as in force prior to the coming into force of the Second Repealing Regulations, 2022.
