**PUBLIC HEALTH ACT
(CAP. 465)**

Period of Quarantine (Amendment No. 7) Order, 2021

IN EXERCISE of the powers conferred by article 27(c) of the Public Health Act, the Superintendent of Public Health has made the following order:-

1. (1) The title of this order is the Period of Quarantine (Amendment No. 7) Order, 2021 and this order shall be read and construed as one with the Period of Quarantine Order, hereinafter referred to as "the principal order".

Citation and commencement.

(2) This order shall come into force on 21 October 2021.
