Dear Medical Practitioner / Dental Surgeon

The Medical Council of Malta is the competent authority for the registration of Medical Practitioners and Dental Surgeons in Malta. It is not the competent authority for employment matters. Please be informed that registration with the Medical Council gives the right to seek employment in Malta, but does not provide employment automatically. Please also note that it is a criminal offence to work as a Medical Practitioner in the Republic of Malta, without holding registration with the Medical Council.

Kindly be informed that the Medical Council will only be able to assist you upon the receipt of a duly filled application form and submission of documentation requested in the checklist (Application page 2). Please find a brief outline of the procedures:

1. A medical / dental practitioner needs primarily to be granted registration with the Medical Council Malta (Please refer to the application form and a set of explanatory notes). Please provide us with all the documents listed in the Check list. If possible please also send us the transcript of your qualification. Having received a duly filled application form and all the documents listed by post, the Medical Council will discuss your case and inform you accordingly.

It is important to outline that the Medical Council will not be able to proceed with your application until the Original (for verification) / Authenticated copies are received by post. Please also note that an Original Certificate of Good Standing, that is, a document issued from the competent authority of the country where you are registered and practicing (valid for three months from the date of issue) needs to be provided.

2. After getting registration with the Medical Council, if being a specialist, one must submit application for accreditation with the Medical/Dental Specialist Accreditation Committee (SAC). For more information please access the following website:
