Report on the Medical Council Malta Statutory Examination for Medical Practitioners Wednesday 16th April 2014

29th May 2014

To the President Medical Council

The Medical Council Malta appointed Ms Gabriella Abela, Member of the Council, to act as the Examination Coordinator for the Medical Council Malta Statutory Examinations (MCMSE) for Medical Practitioners, during year 2014. This was unanimously decided during Council Meeting No. 19/2013, held on Wednesday 27th November 2013.

Ms Gabriella Abela liaised with the Examiners and with the Medical School in Mater Dei Hospital, in order to set up the April session MCMSE and the schedules.

The Medical Council Malta Statutory Examinations (MCMSE) for Medical Practitioners was scheduled on Wednesday 16th April 2014.

In the meantime, the Registrar of the Council provided full information on how to apply to all the twenty-three (23) candidates included in the waiting list for the MCMSE April session, by means of email dated 18th March 2014. The waiting list included applicants who had submitted their application for registration in Malta since the MCMSE held on Wednesday 18th September 2013 and who were requested to sit for and successfully pass the MCMSE in order to be granted registration in Malta.

Candidates were requested to confirm their attendance, and to provide the Council with a recent Certificate of Good Standing (valid for 3 months upon the date of issue) and a detailed Curriculum Vitae (CV), by Monday 31st March 2014. Candidates were also to pay the amount of €1164.69 (as per Legal Notice 330/2006) by Monday 7th April 2014.

Three (3) applicants confirmed their attendance, however, none of them effected payment by the date stipulated.
